ORDER

WHEREAS, recognition was granted to the institution namely MIT KOTHRUD COLLEGE, MAHARASHTRA ACADEMY OF ENGINEERING & EDUCATIONAL RESEARCH, PLOT NO. 124, M.I.T. KOTHRUD, DISTRICT- PUNE MAHARASHTRA for M.ED (Co-Ed) course vide order No. and WRC/5-6/114th/2009/51485-51490 dated 21.02.2009.

2. AND WHEREAS, the institution has applied for change of name from MAHARASHTRA ACADEMY OF ENGINEERING & EDUCATIONAL RESEARCH to MAEER's MIT SCHOOL OF EDUCATION & RESEARCH vide letter dated. 10.12.2013.

3. AND WHEREAS, the matter was placed before the Western Regional Committee in its 234th WRC meeting held on November 03-05, 2015 and the Committee decided that "...This case relates to a change in the name of the institute. The WRC had changed the name of the institute to MAEER's MIT School of Education and Research vide letter dated 03.08.2015. The institute had requested the WRO to issue a revised order also for its M.Ed. programme. While a decision about revised order is pending, the order of change of name be issued.

Order for change of name be issued.

4. AND WHEREAS, the Change of Name order issued to the institution on 15.04.2014.

5. AND WHEREAS, WRC issued Revised Recognition Order to MAEER's MIT SCHOOL OF EDUCATION & RESEARCH, PLOT No. 124, M.I.T. KOTHRUD, DISTRICT- PUNE MAHARASHTRA vide order dated 05.12.2015 for conducting M.Ed. course with an annual intake of 50 students of two year duration from the academic session 2015-2016.

7. AND WHEREAS, the institution has request for Change of University and applied for change of Name of the institution vide letter dated 28.11.2019 received in WRC on 29.11.2019 with D.D. No 045279, Axis Bank, Rs. 1,50,000/- receipt no 17011 dated 15.11.2019.

8. AND WHEREAS, the matter was placed in 313rd and 314th Meeting of WRC held on 25th-27th February 2020 and July 13th-15th, & 22nd 2020 and the Committee considered the matter and observed as under:-

- (i) The institution submitted an application for change of affiliating university as well as change of name of the institution vide application dated 15/11/2019.
- (ii) The proposed university has been gazette notified in the State of Maharashtra.
- (iii) The existing institution MAEER's MIT School of Education and Research, Pune Maharashtra for M.Ed. programme with an annual intake of 50 students vide

Revised Recognition Order No. WRC/APW06394/125133/2015/156645 dated 05/12/2015.

- (iv) The institution has submitted NOC from the previous and proposed university.
- (v) The land documents and sponsoring Trust/Society of the previous institution and proposed university are same.


In view of the above the Committee decided to allow the change of name of the institution as well as affiliating body as under:-

- (i) The name of the existing institution is allowed to be changed from MAEER's MIT School of Education and Research, Pune, Maharashtra to Dr. Vishwanath Karad MIT World Peace University, School of Education, Pune, Maharashtra from the **date of issue of Gazette Notification by Govt of Maharashtra notifying the University.**
- (ii) The affiliating University be changed from existing Savitribai Phule University, Pune, Maharashtra to Dr. Vishwanath Karad MIT World Peace University, Pune, Maharashtra from the **date of issue of Gazette Notification by Govt of Maharashtra notifying the University.**

Correction letter be issued to the institute in this regard"

9. NOW, THEREFORE, the permission is hereby granted for change of Name of institution from MAEER's MIT SCHOOL OF EDUCATION AND RESEARCH, PUNE, MAHARASHTRA, to **DR. VISHWANATH KARAD MIT WORLD PEACE UNIVERSITY, SCHOOL OF EDUCATION, PUNE, MAHARASHTRA** and change of affiliating body from SAVITRIBAI PHULE UNIVERSITY, PUNE MAHARASHTRA to **DR. VISHWANATH KARAD MIT WORLD PEACE UNIVERSITY, SCHOOL OF EDUCATION, PUNE, MAHARASHTRA** for its M.ED. course with an annual intake of 50 students (one Unit).
