## About MIT-WPU

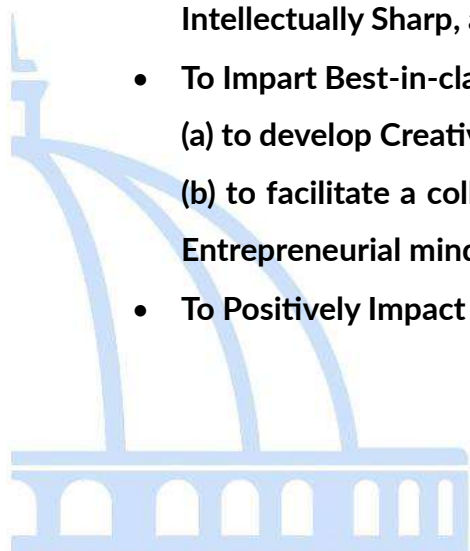

## Admission Policy

Since its inception, MIT-WPU has set a benchmark in higher technical education across the country. The university provides a platform for students from numerous Indian states and even abroad. MIT-WPU has consistently fostered a culture of diversity, tolerance, and acceptance.

With an alumni base of over 1,00,000 individuals contributing to various organizations in India and abroad, MIT-WPU offers an opportunity to learn from experts and thrive in professional life.

## Admission Procedure

### Indian Candidates

- Notifications and advertisements about the application forms and important dates will be published on the MIT-WPU website.
- Application forms can be filled out online on the MIT-WPU official website by paying the non-refundable fee of ₹ 1,800/- for the entrance examination and admission processing. This payment can be made through the online mode (Net Banking/Card/G-Pay, etc.)
- Admissions will be purely based on the Ranks/Percentile/Scores secured in the All-India National Level Entrance Tests/ Maharashtra CET/ MIT-WPU CET conducted by university through online mode which would be consistent with the Computer Based Test (CBT) & Personal Interaction (PI)/ Media Report/ SoP/ Drawing Test/ Portfolio (as applicable) and based on suitable eligibility criteria program-wise.
- The Results of the selection will be published on the individual applicant dashboard.
- Eligible candidates will be allocated programmes based on their ranks/ Percentile/ Scores in the respective entrance examinations, and/or qualifying examinations as per eligibility & the merit cut-offs defined for the relevant selection process.

### International Candidates

- Admissions will be based on marks or grades obtained in the qualifying examinations as per eligibility criteria, and availability of seat(s). The admissions process is based on a first-come, first-served basis.

### Application Submission - Online

The application shall be submitted via the website. Link: <https://bit.ly/49v5pXj>

Candidates should fill out their personal information and contact details (email address & phone number) properly, as all the important updates will be communicated to registered email ID & phone number only.



The important instructions regarding entrance test, personal interaction, and selection process will be communicated from time to time and the candidate should check the details on MIT-WPU official website and on their registered email ID.

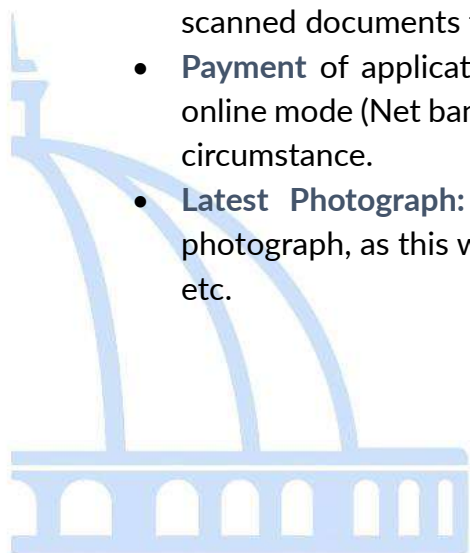
### Important instructions for filling the online application form.

- **Personal Profile:** The name of the candidate and his/her parents must be the same as mentioned on their class 10<sup>th</sup> std. marksheet/certificate (No prefix should be used).
- **Registered contact details:** Please ensure the contact details mentioned in the application form are accurate.
- **Academic Profile:** The candidate should enter the marks obtained in qualifying examinations (10<sup>th</sup>, 12<sup>th</sup>, Bachelor's Degree marks etc). If the qualifying examinations result is not declared, then the candidate should enter the marks within 5 days from the date of declaration of results.

The score of National level Entrance Test(s)/ Maharashtra CET (as applicable) should be updated in the application form within 5 days from the date of declaration of results.

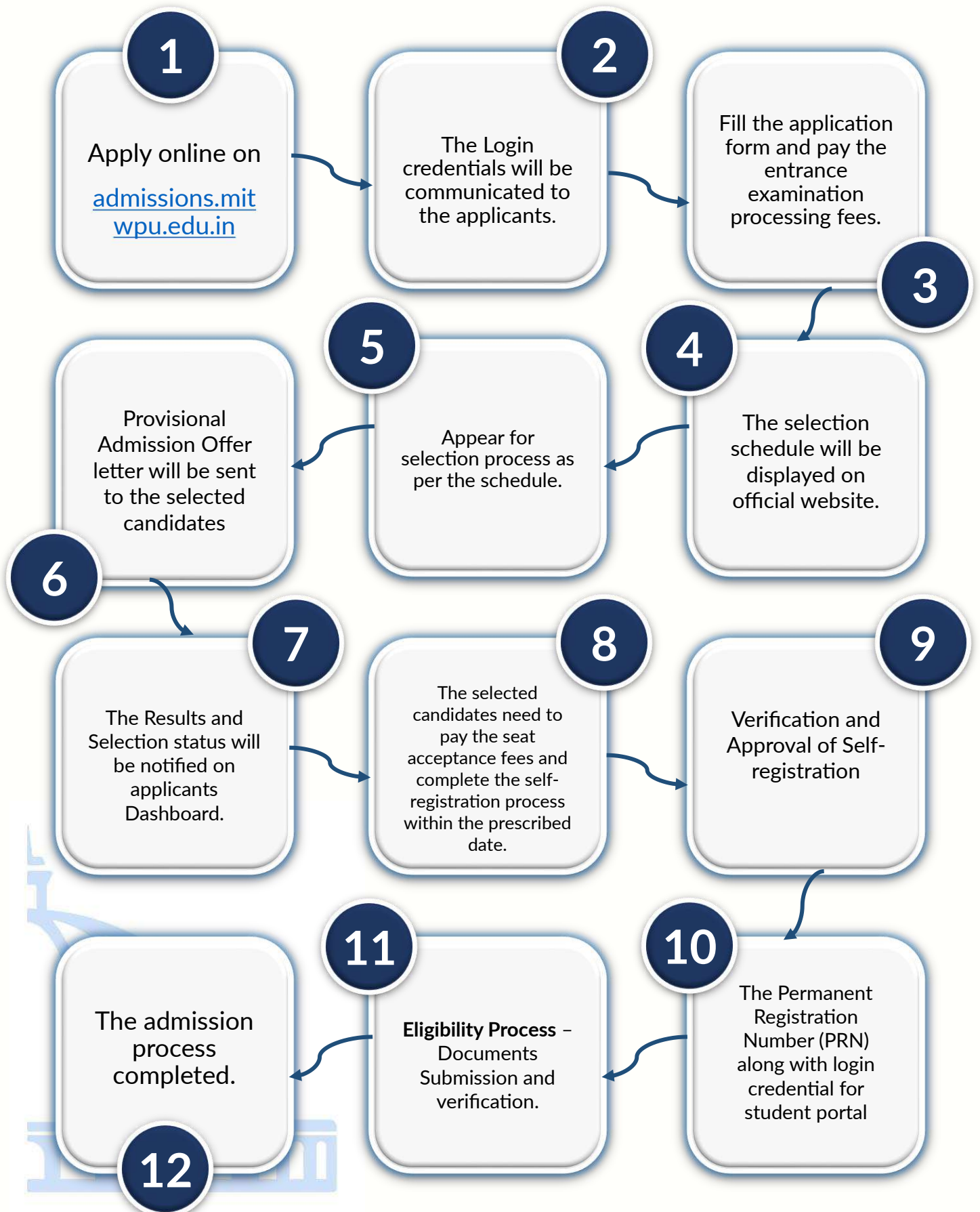
The candidate should upload the score card(s) of respective entrance examination and qualifying examination marksheet(s) accordingly. Applications with incomplete and without qualifying marks/ entrance score/ marks will not be considered for further selection process.

- **SOP (Statement of Purpose):** The SoP should be submitted through online mode in the application form (wherever applicable). A SoP, also known as a letter of intent/ video, is written statement addressed to the admission panel and can be talks about your career path, interests, professional contributions, goals, and the driving force behind pursuing a particular Pedagogy/ Programme.
- **Upload Documents:** We prefer required documents downloaded through DigiLocker or self-attested scanned and readable copies in the application form. The documents downloaded through DigiLocker/ Readable self-attested scanned documents to be kept handy while submitting the application form.
- **Payment of application fees for the entrance examination ₹ 1800/-** through online mode (Net banking/Card/G-pay, etc.) which will be non-refundable in any circumstance.
- **Latest Photograph:** The candidate must upload the latest passport size photograph, as this will be used for further official record(s) like student ID card etc.

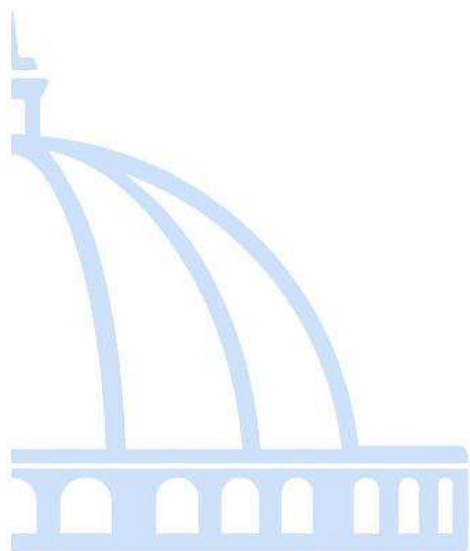




## Application and Admission Process:



- Allocation of seats is based on merit in the National Entrance Examination/ Maharashtra CET/ MIT-WPU CET etc.
  - The Programmes for which CET is not applicable, the allocation of seats is based on board/ degree examinations score.
  - MIT-WPU will not be responsible if any candidate misses to attending the entrance/ admission round/ the counselling round on the respective dates allotted.
  - There won't be any change in the date of the entrance/ admission round/ the counselling round for the candidate.
  - Candidates will be allocated seats based on merit, and vacancies.
  - The Result Status will be communicated as follows: -
    - **SELECTED:** The candidate has been selected based on the selection/merit criteria and must proceed with the further admission process, including fee payment, self-registration, eligibility verification, and submission of original documents as required.
    - **WAITING:** The candidate is on the waiting list and may have to wait for the updated status of the merit list.
    - **HOLD:** The candidate's application is on hold due to incomplete information or requirements, such as unsubmitted entrance examination scores, educational marks, or mandatory tests. These candidates may update the necessary details and await the next merit list declaration.
- OR
- The applicant is on hold for consideration in next/ upcoming round(s) and subject to availability of vacant seat(s).
- **REJECTED:** The candidate has not met the selection criteria for the specified course/programme and is therefore not selected.



## Eligibility

### Indian National Candidate

- **UG Programmes:** The candidate must have passed the 10<sup>th</sup> (SSC), 12<sup>th</sup> (HSC) from state boards/ CBSE/ ICSE/ IGCSE(ICE), IB-Diploma & any other recognised board by the competent authority. All International Baccalaureate (IB) students are required to have a minimum 24 credit points with awarded IB-Diploma. An equivalence/ conversion certificate is required from the respective board/ AIU in case the result is in grade/credit points.
- **PG Programmes:** The candidate must have a Bachelor's Degree or its equivalent Degree from any recognized University approved by the UGC/ AIU.

#### 1. Maharashtra state (MS) Candidates -

A Candidate who is either **Domicile** of Maharashtra and/or is **born** in Maharashtra.

#### 2. Other than Maharashtra state (OMS) Candidates -

A candidate whose Domicile Status is outside Maharashtra and has passed his qualifying examination from Board/University outside Maharashtra will be considered as OMS candidate.

AND/OR

A candidate whose Domicile Status is outside Maharashtra state but passing **10<sup>th</sup> (SSC)/ 12<sup>th</sup> (HSC)/ Diploma or Graduation, Post-Graduation** or its equivalent examination from a recognized school in the State of Maharashtra, will be considered as OMS candidate.

### University Transfers

MIT-WPU Offers admissions to various second-year Undergraduate Programmes across various streams. It can be a great opportunity for aspirants who wish to take admission at MIT-WPU by transferring from another University at the end of their first year to MIT-WPU.

- The candidates will be offered programme based on the availability of vacant seats.
- Candidates can fill out the University Transfer form available on the online application portal of MIT-WPU. The paid application fee is non-refundable.
- If the number of applications received is more than the vacant seats in the program/course, the admission offers will be based on merit for the particular programme for Second Year Admissions.
- The application can be considered for Second Year admission at MIT-WPU based on the equivalence of the subjects as well as the syllabus that the candidate has studied during the First Year and the subjects and syllabus of MIT-WPU for the First Year.

- The MIT-WPU equivalence committee's decision will be final for offering the Second-Year University Transfer Admission.
- If the candidate has not attached the Result for First Year, and an attested copy of the syllabus of the previous university, the application will not be considered for further admission process.
- All matters of dispute will be subject to the legal jurisdiction of Pune, Maharashtra only.

### Important instructions for University Transfer admissions:

The candidate must submit the following documents to the MIT-WPU within 10 days from the date of confirmation of admission.

1. The Original Leaving or Transfer Certificate issued by the previous Institution /University.
2. A Migration Certificate issued by your previous University.
3. Attested copy of First Year result (basic eligibility is passed with no backlog in the examinations).
4. A copy of the Aadhar card and Permanent address proof.

## International Candidate

- **Under-Graduate (UG) Programmes:** The candidate must have passed the Std. 10+2 or its equivalent examinations from the recognized institution approved by the Government.
- **Post-Graduate (PG) Programmes:** The candidate must have a Bachelor's Degree or its equivalent Degree from any recognized University approved by Government (AIU).

MIT-WPU follows UGC-specified eligibility norms while reviewing international students' admission applications. To take admission for any programme at MIT-WPU under international category, the admission categories of international candidates are as mentioned below:

**A. Foreign Nationals Students:** A student is eligible to apply as a Foreign National (FN) if he/she is a citizen of any country other than India and holds a foreign passport (FN - SAARC countries: Afghanistan, Bangladesh, Bhutan, Maldives, Nepal, Pakistan, Sri Lanka and FN-Non-SAARC Countries).

**B. CIWGC/CIWSEA Students:** Children of Indians working in Gulf Countries & Southeast Asian countries, (the candidates whose parents are working at Gulf countries or Southeast Asian countries) only are eligible under this category.

**C. OCI Students:** A student is eligible to apply as OCI if he/she has been granted Overseas Citizenship of India and has an OCI card.

**D. NRI:** A student is eligible for NRI Category if he/she is a Non-Resident Indian (Other than Gulf & Southeast Asia Countries).

MIT-WPU Offers attractive scholarships to all our International Category students (Refer Annexure 2).

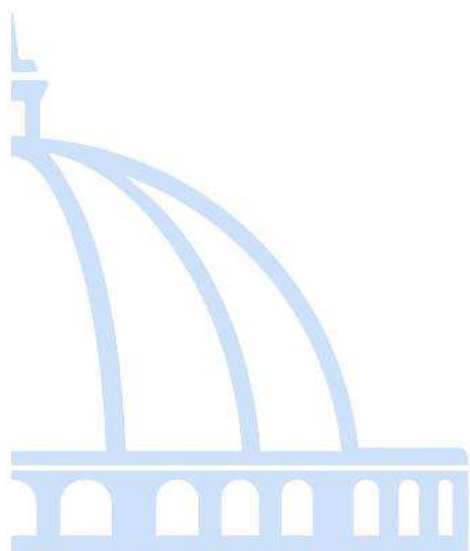
**Note:** Admission Eligibility Criteria, and fee structure are specific to each programme. Kindly check the respective programme pages of our official website.

**Additional Documents required for International/NRI/Foreign candidates:**

- Student & Parent Passport Copy (Passport copy submission is mandatory).
- Original Employer Certificate (If applicable).
- Original Sponsorship Letter (If applicable).
- NRI certificate (Applicable for NRI category students).

**Important Note:**

- For detailed programme wise eligibility criteria, please refer Annexure 1 mentioned below and/or refer MIT-WPU official website for programme wise eligibility.
- MIT-WPU retains the right to make changes to any published schedule.
- The eligibility criteria defined and declared by the appropriate authority, university from time to time will apply to all applicants.
- Applicants must carefully review the eligibility criteria for their chosen programme(s) before completing the application form. The University reserves the right to disqualify any candidate at any stage of the admissions process if they are found ineligible or have provided false or incorrect information. In such cases, the candidate's provisional admission will be cancelled.



## Programme Eligibility & Selection Process: Annexure 1

- MIT-WPU retains the right to make changes to any published schedule, selection criteria, eligibility criteria etc. at any stage of admissions.
- In case class 10<sup>th</sup>/ 12<sup>th</sup>/ Graduation/ Post Graduation results are not declared at the time of provisional admission, the completion of eligibility process & documents submission will be sole responsibility of the candidate before commencement of classes.

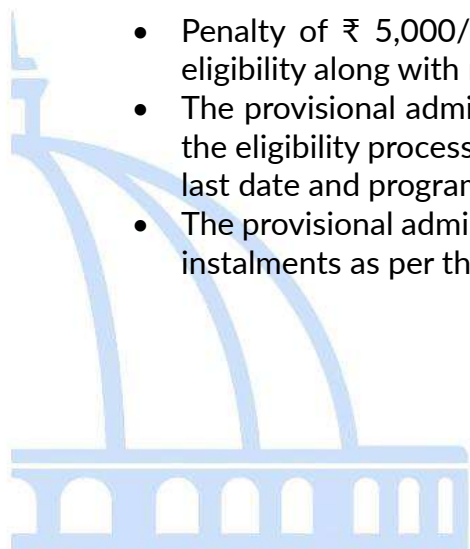


## Note

- For Post-graduate and Ph.D. Programmes Graduation and Post-Graduation marksheets of all semesters are required at the time of self-registration/eligibility verification without fail with the above documents.

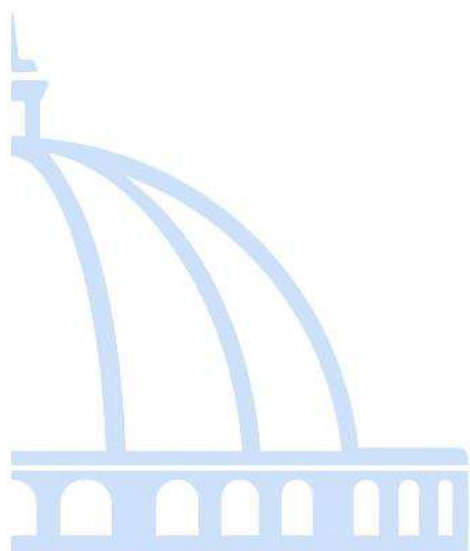

Any candidate who participates/wins a medal at west zone inter-university, all India inter-university, national or international level, while representing MIT-WPU or playing for any Govt. sponsored/ Govt. recognized official sports organization [IOA, BCCI, etc.]; in any nationally/ internationally recognized sporting event; in individual or team sports; would be eligible for the following scholarship for the remaining period of the Programme, only if he/she participates and wins a medal on the National / International Level.

If the student has secured a top 5 ranking position in a tournament (Badminton, Chess, Table Tennis, Shooting, Archery etc.) conducted by or affiliated with a recognized govt. sponsored/Govt. official sports organization or federation at National or International level, then he/she will be eligible for the participation scholarship.

As per the Academic calendar, (i.e., from 1st June – 31st May), if a student has secured a medal/rank in his 12th std. then he/she can apply for the scholarship, provided all the criteria is met, in the 1st year itself. Securing a rank in 1st year, will result in a scholarship being awarded in the 2nd year and so on. In case, a student is in the last academic year, then he/she can apply for a reimbursement in the same academic year only.

Note: An individual or team winning at West Zone, All India level, National or International level would be eligible for any one concession (whichever is higher).

**6. Hon'ble Shri. T N Seshan Scholarship:** This special scholarship is offered to candidates admitted to the School of Government.

The students at the School of Government who are the wards of in-service public servants with a minimum of 5 years of experience in government service shall receive the "Hon'ble Sri. T N Seshan Scholarship" which amounts to 15% of the Programme fee.

**7. International Scholarship:** This scholarship is offered to students from the CIWGC, CIWSEA, OCI and Foreign Nationals candidates. International Scholarship cannot be clubbed with any other scholarship.

The criteria for awarding the scholarships for various Programmes and categories are given in the subsequent paragraphs.

- For all international candidates, 50% of domestic fee waiver will be awarded by MIT-WPU in the form of a scholarship (except NRI Category).
- All scholarships will be awarded on A FIRST-COME, FIRST-SERVED BASIS.
- Academic performance & attendance should be maintained throughout all semesters of every year for the continuation of the scholarship.

## Fee Concession:

### 1. Wards of MIT-WPU/ MAEER's Staff Members:

- Applicable to the wards/ spouses of the faculty/ staff members who are in three (3) years continuous employment at any institute/ college/ University under MAEER's at the time of Admission.
- The scholarship would be applicable for the entire duration of the Programme admitted.
- If the faculty/ staff leaves the organization due to termination/resignation or any other reason, the applicable fees for that year shall be payable in full. The scholarship won't be applicable.
- For claiming this scholarship, the student must obtain a minimum of 60% marks in the qualifying examination at entry level.
- This fee concession will not be applicable to wards of employees who have taken admission in academic year prior to 2024-25.
- The amount of the scholarship is based on the gross salary per month of the employee. The scholarship as a percentage of fees is given below.

## 2. Alumni:

- Any Alumni or spouse of Alumni or ward of Alumni (son/daughter) from any School/ College/ University of MAEER Group who takes admission to MIT-WPU will be eligible for a scholarship of 10% of fees for the entire duration of the Programme provided he/she scores a minimum of 60% marks/grade in the qualifying examination at entry level and for continuation the student must progress to the next level without any live backlog. Proof of alumni registration is required to obtain the concession.

## 3. Prime Minister's Special Scholarship Scheme (PMSSS):

- The candidate admitted directly through AICTE under PMSSS, will have to pay the international study tour cost component, either at the time of admission or before the tour, if he/ she wishes to go for the international study tour. This international study tour shall be completely optional for students admitted under the PMSSS quota.
- Also, the candidate shall apply for an online scholarship under the said scheme & shall be granted the scholarship/ fee concession only for the amount that is equal to the difference between the total fee & the amount reimbursed from AICTE which shall be applicable for the entire duration of the Programme.

## 4. Defence:

- Wards of personnel working in or retired from the Defence Services/ Para-military services are eligible for a scholarship across the duration of the programme. The scholarship would be 25% scholarship for the wards of Non-Commissioned Officers (NCO's), 15% for the wards of Junior Commissioned Officers (JCO's) & 10% for the wards of Senior Commissioned Officers.

## 5. Differently Abled Student:

- Students with 40% & higher disability will be given scholarships amounting up to 40% of fees depending upon disability. The disability must be certified by a medical authority specified by the government. Scholarship is applicable across the duration of the programme.

## 6. GOI (Government of India) Student:

- Seats allocated through Central Seat Allocation Board for North-Eastern States & Union Territories [CSAB NEUT] to be conducted by NIT.
- Scholarship / Fee Concession equal to 50% amount of the total fee will be granted for the entire Programme duration. It will be a subject to good behaviour, discipline & passing in university examinations.
- These students would not be eligible for any other scholarship other than those covered under the Rank holder or Elite sportsman Scholarship.
- The scholarship will continue only if the student progresses to the next year without any break/live backlog/failure.



## 7. Jammu & Kashmir Migrant:

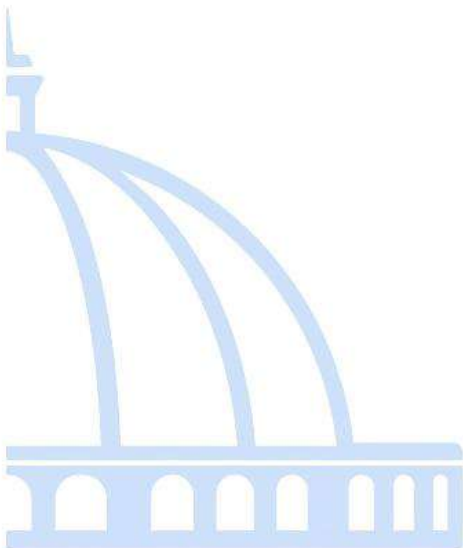
- Only one seat per division of 60 will be allotted based on merit to a candidate eligible for seeking admission under J & K migrant quota, which would be over & above the regular approved intake for the said Programme.
- Scholarship /Fee Concession equal to 50% amount of the fee will be granted for the entire Programme duration. It will be subject to good behaviour, discipline & passing in university examinations.
- These students would not be eligible for any other scholarship other than those covered under the Rank holder or Elite sportsman Scholarship.

### Terms and Conditions to award and continuation of the Scholarships/Concessions:

- Scholarship shall be awarded to eligible students on a first-come, first-served basis.
- The number of scholarships is being awarded proportionate to actual admissions and not more than percentage of the approved intake of the respective Programme.
- Scholarship is not awarded in cash but is adjusted in the fees.
- If there are more eligible candidate for one scholarship slab, the overflow from the allocated scholarship candidates will be shifted to next slab.
- No two scholarships will be given concurrently except the scholarship for the MAEER/MIT-WPU Employee concession and Alumni concession. In such cases the total amount of the scholarship/concession should not exceed 75% of the total academic fees.
- **Academic Performance (Domestic):** To continue the scholarship for the total duration of the Programme, the student should maintain a minimum Cumulative Grade Point Average (CGPA) of 8.0 and above of every year with no live backlogs in any subject/ programme and no semester break.
- **Academic Performance (OCI/CIWGC/CIWSEA/FN):** To continue the scholarship for the total duration of the Programme, the student should maintain a minimum CGPA of 6.0 and above, throughout all semesters of every year.
- **Attendance:** The student must maintain a minimum attendance of 80% per semester after catering for all exigencies including illness, sports, and any other requirement. (75% minimum attendance for International Category Students).
- **Discipline:** The student must maintain good conduct, behaviour, and discipline as per the Code of Conduct of the University. For any violations of the University Code of Conduct, the student will be issued a written

warning/memo leading to forfeiting of the scholarship immediately for ongoing as well as the subsequent years.

- In case of cancellation of admission, the scholarship would stand 'null & void', and the student must pay back the total fee waiver given to him/her by the University till the time of cancellation of admission.
- MIT-WPU reserved rights to utilize the scholarship awardee for promotional activities.

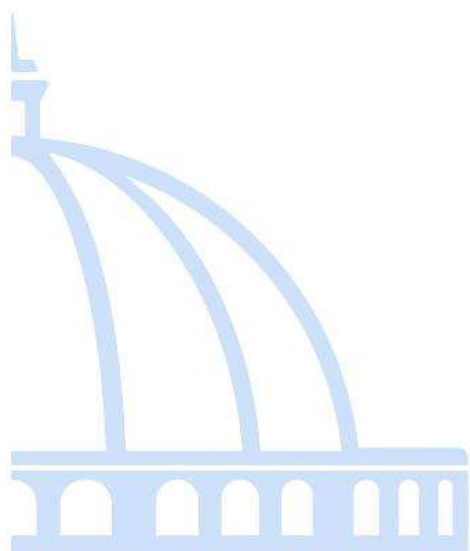

- Rural, National Academic and Global Academic Immersions are not part of Standard Fee Structure (where applicable).
- NRI and FN (including SAARC) category will have the fees option of two instalments, whereas CIWGC, CIWSEA & OCI will have to pay the fee in one instalment.

## Annexure 3 – Tuition Fees Policy

### Introduction

This policy outlines the procedures and guidelines for students who choose to pay their university fees in instalments. It aims to provide clarity on the deduction process, penalties for late payments and the academic implications of delayed payments. This policy ensures that all students are aware of the consequences of late payments and the utilization of collected penalties for student welfare activities.

### Scope

This policy applies to all students at the university who opt to pay their fees in multiple instalments. It covers the payment structure, penalty mechanisms, academic consequences of late payments and guidelines for fee refund after admission cancellation.

### Objectives

- To provide a clear structure for fee payments in instalments.
- To ensure timely collection of fees to maintain the university's financial health.
- To impose standardized penalties for late payments to encourage timely fee payment.
- To utilize collected penalties for student welfare activities.
- To align with UGC guidelines for admission cancellations.

### Policy Details

#### Fee Payment Structure

The University shall adhere to all necessary and timely guidelines issued by the University Grants Commission (UGC) regarding the payment and refund of fees while processing any student's fee-related issues.

Students who choose to pay their fees in multiple instalments will have the components of their fees deducted sequentially as outlined below:

- (i) Deduction of Tuition Fees
- (ii) Deduction of Exam Fees
- (iii) Deduction of outstanding Penalty (If any)

#### Penalty for Late Fee Payment

- (i) A penalty of Rs. 250/- per day will be imposed for late fee payments. This fine is a fixed amount and does not vary based on the number of instalments.
- (ii) The penalty is not imposed on the Examination Fees of the university.

#### Utilization of Penalty Amount

The amount collected from student's penalties will be utilized exclusively for Students Welfare activities.

#### Attendance and Continuous Assessment

Any loss of attendance or class continuous assessment due to late payment of fees will remain to be the individual responsibility of the student and will not be compensated.



## Admission Cancellation

The admission cancellation process will be in adherence with the yearly guidelines provided by MIT-WPU and/or the University Grants Commission (UGC).

## Cancellation of Admission & Refund of Fee Policy:

MIT-WPU will consider any request for cancellation/withdrawal of admission from students only if such a request is made by the regulations prescribed by the university. The regulations include the procedure for cancellation/withdrawal of admission as well as the rules for refunds.

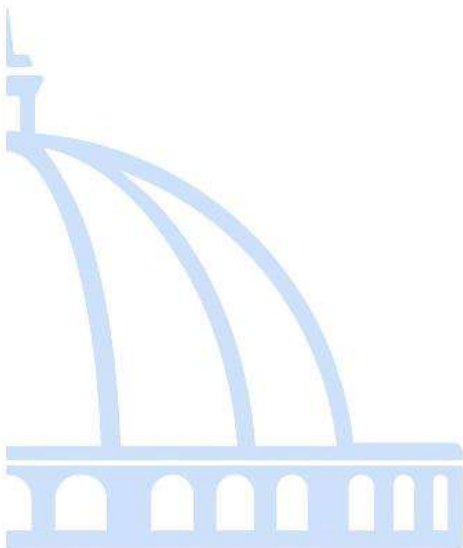
### Conditions

- A request for cancellation of admissions must be sent through the registered email of the candidate to the email address mentioned in the offer guide or from the University Student Portal. No other method will be accepted.
- A refund will be made as per the university norms and UGC norms.
- A refund will be made only after the submission and verification of the proof of fee paid, the provisional seat and the allotment letter. The refund will be made through an account transfer to the account number mentioned in the withdrawal request. Hence, the correct bank account details must be provided in the withdrawal request.
- A refund would be considered only in respect of the Programme/Academic Fee paid by the applicant. No refund shall be allowed in respect of Application Fees, entrance examination, or any other levies.

- In case the student fails to fulfil the eligibility criterion, then the student must communicate the same to the university within 10 days from the date of the declaration of the result from the concerned Board or University. (If the student fails to do that and the seat remains vacant, then the university will refund the fee paid after deducting ₹ 10,000/-; else no refund shall be admissible)

### Important Notes

- All refunds shall be remitted only to the bank account of the student/parent as per the NEFT details furnished by the applicant and shall be made within 30 working days from the date of approval of the cancellation or withdrawal.
- If the student has submitted a fake score, then the student is liable to be cancelled for the admission, without any intimation and without refund of fees at any stage during his tenure at the university. In such cases, legal action may be taken.
