

Note: Refundable security deposit of Rs. 25000/- has to be paid along with the 1st Installment.

- The payment for the second installment is due before December 15th, and failure to meet this deadline will result in the application of late fees as per our policy.
- Security Deposit will be refunded only after full hostel fee amount paid by the student.
- Note: Fine of Rs. 250 per day is applicable from the last revised due date until the full fee amount is paid.
- Validation of Hostel Accommodation till 15th June 2027.

- + Payment is to be made online. The MIT-WPU hostel admin team will share the link with the parents. Once the payment is made, the same will be confirmed by the MITWPU hostel admin team.
- + Post verification of the payment receipt, a bed will be allotted under the name, and the details of the allotment will be shared by the MIT-WPU hostel team.
- + A monthly electricity charge of ₹300 per student applies to both AC and non-AC rooms. In case the actual electricity usage exceeds this limit, the student will be responsible for paying the additional amount.
- + Room allotments shall be made on a first-come, first-served basis, based on the application submitted by the candidate in a prescribed format. The hostel room is allotted only to those who have made the full university fees and hostel fees, including mess.
- + Admissions begin in the month of August each year. In case of late admissions, the fees will be calculated on a pro-rata basis.

Ragging

- + RAGGING IN ANY FORM IS BANNED INSIDE AND OUTSIDE THE CAMPUS. STRICT ACTION WILL BE TAKEN AGAINST THOSE INDULGING IN RAGGING. SUSPENSION AND OR WITHDRAWAL FROM THE HOSTEL/COLLEGE IS ONE OF THE ACTIONS TAKEN IMMEDIATELY. PUNISHMENT FOR RAGGING UNDER THE "UGC REGULATIONS ON CURBING THE MENANCE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, 2009" WILL BE APPLICABLE FOR THOSE WHO INVOLVE IN SUCH ACTIVITIES.
- + **An undertaking by the Student, Parent/Guardian is required to be signed as per UGC Regulation 2009, Annexure I (Part 1) and Annexure I (Part 2) at the time of Hostel Admission.**

Bus Allotment Policy

- + Buses will be allotted based on the slots for the particular programs, as communicated by the University in sync with the academic calendar of the university.
- + The bus schedule will be given to the students upon joining the hostel as per the academic calendar of the university.

Common Area/Reading Room/Games Policy

- + All common areas/recreational areas except reading rooms will be closed post 9 pm. Damage/breakage/theft of any assets or articles in the said area will be recovered from the students present in that session by MIT WPU Hostel Residential Warden/s.
- + TT table and snooker –Students need to bring their own rackets and TT balls to play. Damage or misplacement to any of the assets after the session will be recovered from the students present in that session.
- + Board games will be provided by the MIT WPU warden for each session. Damage or misplacement to any of the board games or items in games will be recovered from the students present in that session.

Washing Machine and Laundry Policy

- + Use of washing machine is allowed only for the washing of regular clothes and Towel.
- + Penalties will be issued for the misuse of washing machines.
- + Blanket will not be put in washing machine.
- + Laundry service is designed to provide you with a convenient and efficient way to manage your laundry needs.
- + Pickup & Delivery, Washing, Drying, Ironing & Packing, Personalized pair of laundry bags to every resident with their name, room number and hostel code tagged on it.
- + Inclusive in monthly hostel fees (maximum limit of 10kgs per month per resident) (Above 10kgs resident will need to pay 55/- per kg).

Noise Policy

- + No use of speakers, mobile phones with loudspeakers, or TV is allowed with a sound range above 45 (decibels), as it can disturb the roommates, neighbors, and hostel staff.
- + Any instance of such nature would result in penalties with amount up to Rs 1,000/-
- + Strict silence shall be observed in the hostel from 10:00 pm to 06:00 am. Any manner of festivities/celebrations that may disturb the decorum of the hostel should not be practiced.

Notice Board Policy

- + Notices and flyers on the noticeboards are to be placed only by the hostel authorities.
- + Any misplacement or damage, illicit posters, religious sayings, or fixing notices from students' end on common notice boards would impose penalties up to Rs 500.

Fine for Latecomers

- + Latecomers on or after 9:30pm on any given day, except those permitted by the hostel dean/supervisors/agents, will be liable to pay a fine of Rs. 1,000/- per delay.
- + If the delay continues for a period of more than 3 consecutive days, then the parents of latecomers will be informed about the same and terminate from the hostel.
- + If any latecomer signs or tries to sign on behalf of any other hostel student, then both the latecomer and the student who signs on behalf of the latecomer will be fined, which shall amount to Rs. 1,500/-.

Prohibition of Alcohol/Drugs/Smoking/Gambling

- Use of Alcohol/Drugs/Smoking/Gambling is strictly prohibited in the hostel premises. The university maintains a zero-tolerance if anybody is found violating the instructions. The defaulter individual will be immediately rusticated from the hostel.
- The use or possession of alcohol, tobacco products (including cigarettes), and narcotics (such as cannabis or any other illegal substances) is strictly prohibited within the hostel premises.
 - a. If a student is found in possession of or consuming any of the prohibited substances mentioned above, their security deposit will be deducted as a penalty.
 - b. Any subsequent violation will result in immediate disqualification from residing in the hostel, and the student will be required to vacate the premises with no refund of fees.

Leave Policy

- + No student should stay away from his/ her room during the night, without prior written permission of the warden.
- + Students, who wish to leave the hostel should obtain the permission of their parents by mail followed by telephonic confirmation by the residential warden between 10 am to 6 pm (before 2 days). The application for permission must state, the date and time of his/her intended departure and return, as well as the destination. All these details are to be entered in the in-out register maintained in each hostel.
- + If any student is failing to follow the above instructions will be referred to the Discipline Committee.

Use of Electronic / Electric items and Furniture

- + Fixtures: Students are prohibited from bringing any additional electrical gadgets that require charging or consume power other than the fixtures in the room (excluding mobile chargers and laptop chargers).
- + Damage to electronic/electric items and furniture: During their stay in the hostel, students are expected to take adequate care of the electronic/electric items and furniture provided by the hostel. Any damage to the hostel's property will be recovered from the students.
- + Interchange of Furniture/Fixture: Students are not allowed to interchange any furniture/fixture from one location to another within the hostel. The students involved will be subject to a penalty recovery and may be expelled from the hostel.
- + Assets in Common Areas/Corridors: Theft/damages to hostel assets in common areas/corridors shall be recovered from all students of the flank/wing involved.
- + In case of theft/damage to items that pertain to usage by the complete hostel, the recoveries shall be made from all the occupants of the hostel.

Equipment Tampering / Abuse

- + Tampering with fire extinguishers is prohibited and may invite severe disciplinary action.
- + Tampering/misuse/damage of the following can invite severe consequences: Fire extinguishers, Partitions, CCTV cameras, breakout zone amenities - sofa, washing machine, water cooler, furniture, etc.

Electricity Policy

- + Each student will be charged ₹300 per month towards electricity and air-conditioning. If actual consumption exceeds this amount, the student shall bear the additional cost. All such charges must be paid promptly as per the billing cycle; delays may attract penalties or lead to service restrictions. AC usage is monitored through a prepaid meter system, and charges are calculated based on actual consumption at rates prescribed by the Maharashtra State Electricity Board.

This policy is implemented due to the following reasons:

- Excessive and misuse of Air Conditioners inside AC rooms.
- Extra equipment such as kettles, Room Heater, hot air Blower, Emissions Road, Hair straighteners, induction heaters, and iron were found in the rooms during the audit.
- During housekeeping, it was observed that lights and fans in most of the rooms were left on even when there were no students inside, resulting in unnecessary electricity consumption.

Night Policy

- + The gates will be closed by 9:30 pm
- + The students are not allowed to be in the common area post 10pm
- + The lights on common area will be dimmed post 10pm
- + The lights on the common area ground will be switched off post 10 pm
- + The lift will be operational from 6 am to 10 pm
- + Only students with prior (Before 6 pm) written permission from their professors and subsequent prior approval from the warden will be allowed to enter the hostel premise post 9:30 pm.

Water Policy

Hot water will be made available from 5.30 AM- 9.30 AM and 7 PM- 9 PM every day.

Vehicle Policy

Limited numbers of two wheelers are permitted to bring inside the MIT WPU Hostel campus based on first come first allotment basis, depends on the availability of the parking.

ONBOARDING AND PAYMENT POLICY

General Guidelines

- Onboarding will start a week before the commencement of the respective program.
- KYC completion would be required an Aadhar Card, a passport size photo, undertaking a medical clearing certificate, and local guardian address/permanent address at the time of onboarding.

Fee Structure

- Fees can be paid annually or in two installments .

Payment Deadlines

- 1st installment must be cleared by every student before arrival
- 2nd installment has to be paid before 15th Dec 2026.
- A late fee of ₹250 per day will be charged after the deadline.
- All students must clear their first installment by 15th July 2026 irrespective of their arriving time.

Payment Modes

- Acceptable modes include NEFT, RTGS and UPI
- Cash payments are not accepted.
- Penalty for Dishonored Payments
- Cheque or UPI failures will incur a penalty of ₹500.

Payment Modes

Hostel reserves the right to revise fees annually with 60 days' prior notice.

Clause: Unauthorized Fee Collection and Payment Advisory

All hostel-related payments must be made only through the official / MIT-WPU payment channels, such as the authorized bank account, online payment portal, or the Accounts Department of the institution.

Students and parents are strictly instructed not to make any payments in cash, cheque, or digital mode (e.g., UPI, Google Pay, bank transfer) to any hostel warden, staff member, student, or third party under any circumstance.

The institution will not be responsible for any loss or issue arising from payments made to unauthorized individuals. Any such transactions will be considered invalid, and hostel accommodation or services will not be confirmed against them.

In case any person requests or demands payment outside official channels, it must be immediately reported to the Hostel Office, Admissions Department, Management.

This clause is intended to ensure financial transparency, accountability, and protection for all students and parents.

CANCELLATION POLICY

- From the date of college commencement 7 days should be given for cancellation– Refund time line 45 to 60 working days. -
- Fees will be charged on a pro-rata basis, depending on the number of days stayed in the hostel.
- If a student leaves the hostel after completing one semester, they will still be liable to pay the second installment of the hostel fee.
- All cancellation or refund requests must be submitted through the Student App or via official email only.(hostel.admin@mitwpu.edu.in) Booking amount is nonrefundable.
- Once a student is onboarded no refund will be applicable

Late Admission in collage

Hostel cancellation requests due to late admission will be considered only if submitted within 7 days from the date of onboarding.

- Students will be granted 7 working days after onboarding to make a final decision regarding cancellation.
- The security deposit will not be refunded under any circumstances.
- From the remaining fee amount (excluding the security deposit), a 20% deduction will be applied before processing the refund.
- From the date of college commencement, a 7-day window will be provided for cancellation.
- Refunds will be processed within 45 to 60 working days from the date of approval.
- Valid reasons for cancellation must be mentioned and supported by documentation where applicable.
- Once a student has onboarded and occupied the hostel, no refund will be applicable under any circumstances.

+ General Guidelines

Students must submit cancellation requests in writing or through the official email /app, including their reasons for cancellation. Approval is subject to verification by the hostel administration. Refunds will be processed only after all dues are cleared, including outstanding fees and damages.

+ Refund Timeline and Deductions

The cancellation policy specifies that if a student cancels their hostel admission within 0-07 days of joining, a deduction of ₹5,000 each for hostel and mess charges will be made, totaling ₹10,000. No refunds will be provided for cancellations made after 07 days, with the annual fee being non-refundable under all circumstances. And students who leave after completing one semester must pay the second installment. Cancellations must be notified via the student app or email (hostel@mitwpu.edu.in). From the date of college commencement 7 days should be given for cancellation– Refund time line 45 to 60 working days.

Students who leave after completing one semester are required to pay the second installment of fees.

Cancellations must be notified via the student app or by emailing hostel@mitwpu.edu.in.

From the date of college commencement, students have a 7-day window to request cancellation. Refunds, when applicable, will be processed within 45 to 60 working days.

+ Process for Requesting Refunds

- Submit the cancellation form online or at the hostel office.
- Provide proof of fee payment and relevant documents (e.g., internship letters, medical certificates).

+ Conditions for Refund Denial

- Expulsion due to disciplinary issues disqualifies students from refunds.
- Failure to vacate the room by the specified date post-cancellation forfeits the refundable security deposit.

+ Additional Notes

- **Room Cleaning and Damage:** Charges for room cleaning and repairs will be deducted from the security deposit.
- **Approval Timeline:** Approval for cancellations during vacations or semester breaks requires prior notice of at least two weeks.

REFUND POLICY FOR STUDENT HOSTELS

+ General Guidelines

Refund requests must be submitted in writing through the official portal, app, or email. Refunds are calculated based on the timing of withdrawal and the services used. Security deposits will be refunded only after deducting damages, if any, and clearing dues. Refunds are typically processed within 45 working days.

+ Refund Criteria

The refund is determined based on the time of cancellation:

+ Before Occupying the Hostel

- Full refund of hostel and mess fees after deducting a nominal processing fee (e.g., ₹10,000).
- After 1st August 2026 **No** refund of the hostel fee.

Deductions and Charges

- + • Pro-Rata Deductions: Applicable for mess and room rent based on usage.
- Damage Recovery: Deductions made from the security deposit for damages.

Exceptions

- Refunds for medical emergencies or transfers require valid documentation.
- No refund for students expelled due to disciplinary actions.

DAMAGE POLICY FOR STUDENT HOSTELS

General Principles

+ Responsibility:

All residents are expected to use hostel property responsibly. Damage caused by negligence or intentional acts will incur penalties.

+ Documentation:

Every instance of damage will be recorded, and affected students will receive a detailed letter mentioning the charges. This letter will serve as an official reference.

+ Collective Accountability:

In shared spaces, damages will be the collective responsibility of residents unless specific individuals are identified.

Classification of Damages

+ Individual Room Damages

- Residents are fully responsible for damages in their allotted rooms (e.g., furniture, fixtures, or appliances).
- Cost of repairs or replacements, up to 2x the actual cost, will be charged to the room occupants.

+ Common Area Damages

- Damages in common areas (e.g., lifts, corridors, or recreational zones) will be split among the residents of the concerned floor or wing.
- If damages result from misuse of specific utilities (e.g., microwaves, washing machines), residents using these during the incident will bear the cost.

+ Unidentified Damages

- If no individual is identified, the cost will be distributed among all residents of the area where the damage occurred.
- Investigations by hostel staff aim to educate and ensure similar incidents do not recur.

Charges and Fines

+ Calculation

- Minor damages: Repair costs based on market rates.
- Major damages: Comprehensive repair costs, which may involve external vendors.

+ Fine Deduction

- Fines are deducted from the student's refundable security deposit.
- If damages exceed the deposit, additional charges will be invoiced and must be cleared before the next semester.

+ Reporting and Investigation

- Students are encouraged to report damages promptly to the warden or hostel authorities.
- If damages are reported late, or negligence is identified, higher fines may apply.
- Investigations by hostel staff will attempt to identify the responsible individuals through CCTV footage, witness accounts, or direct admission.

Preventive Measures

+ Guidelines for Residents

- Avoid moving furniture or fixtures to other rooms without permission.
- Switch off lights, fans, and appliances when not in use to prevent electrical damage.

+ Inspection

Periodic inspections will be conducted by the hostel administration to ensure compliance and detect issues early..

Consequences of Severe Violations

+ Disciplinary Actions

Severe or repeated offenses (e.g., vandalism) may result in fines, suspension, or expulsion from the hostel.

+ Legal Liability

If damages are significant, legal action may be pursued against the responsible individuals.

Process for Fine Recovery

+ Notification

Students receive a damage report with detailed charges.

+ Acknowledgment

Students must sign the acknowledgment letter to confirm acceptance of the charges.

+ Payment

Fines will be deducted from the security deposit or billed separately if the deposit is insufficient.

Examples of Fines

- + Tampering with fire extinguishers: ₹5,000.
- + Misuse of lifts: Full repair cost + disciplinary action.
- + Damaging furniture or appliances: Market replacement cost × 2.
- + Leaving lights or fans on in unoccupied rooms: ₹500 per instance.

Policy for Large-Scale Damages

If damages require significant repair efforts or replacement of costly infrastructure (e.g., lift motors or gym equipment), the charges will be apportioned among all residents unless specific culprits are identified.

Elevators In Hostels

- + The elevator/lifts are a common facility provided to residents of the hostel and their upkeep is the responsibility of all the residents.
- + If a student or his/her is found damaging elevators in the property, he shall be required to bear the replacement or repairing cost of the damaged property. Such deviant behaviour would also invite disciplinary sanctions.
- + If the elevators are damaged by unidentified student(s), the hostel staff shall investigate and try to identify the responsible student(s) to educate/empathizes with them. If the hostel staff cannot identify the concerned student(s) after a reasonable attempt, it may charge the replacement/repair costs to the residents of the concerned hostel.
- + Students are encouraged to report any such information that can help identify the responsible person(s).
- + If a student drops items into an elevator shaft, s/he should report the issue to the concerned student support.
- + If the student can wait till the time of routine service of the lifts, the item(s) retrieved shall be returned to the student at no charge. However, the student shall be charged the full cost of the technician's visit if s/he demands it specifically to retrieve his/her item/s.
- + If in any case, a student causes damage to lift LOP, door, fan, light, or camera, the student shall be responsible for bearing the charges of lift AMC.

Fire Hazards and Safety

- + Candles and incense are a fire hazard and are not permitted in the hostels.
- + Combustible materials such as gasoline, paint thinner and oil lamps are not permitted as well.
- + **BURSTING CRACKERS, CARRYING CRACKERS TO THE ROOMS AND LIGHTING LAMPS/CANDLES ARE STRICTLY PROHIBITED IN AND AROUND THE HOSTEL PREMISES AT ALL TIMES.**

Students should adhere to the following rules and regulations.

- + The students are required to be present only during the specified times for breakfast, lunch, and dinner.
- + The students are expected to maintain proper decorum during mess hours.
- + Waste of food must be avoided.
- + Separate dining sections are available for boys and girls; they should not sit together during meals.
- + No student is allowed to take food from the dining area to their rooms, in case of medical conditions, they are required to get permission in advance.
- + Mess properties should not be taken outside the mess premises. Doing so will result in a penalty is Rs. 500/-.
- + Non-hostellers shall not be allowed to enter the Hostel premises.
- + Members are requested to show ID Card whenever required/demanded.
- + Certain items are limited at the discretion of Hostel Management.
- + Mess Holidays would be in sync with the academic calendar.

CODE OF CONDUCT FOR HOSTEL STUDENTS

1. Eligibility and Registration

Hostel accommodation is available only for bonafide students actively enrolled in a university course. Students must occupy the rooms allotted to them and cannot change rooms without written approval from the warden.

2. Daily Operations

Attendance: Must be marked daily between 9:30 PM and 10:00 PM.

Timings: Entry allowed only between 6:00 AM and 9:00 PM. Late arrivals require prior permission and are subject to disciplinary action.

3. Behavior and Conduct

Students must conduct themselves with dignity and decorum.

Prohibited Activities:

- Alcohol, drugs, smoking, gambling, and physical/mental harassment (e.g., ragging, abusive language, violence).
- Cooking in rooms (allowed only in common areas). This is subjected to the availability of cooking area of respective hostel.
- Bringing pets or feeding stray animals inside the hostel premises are not allowed.
- Dress Code: Decent attire is mandatory.
- Silence must be maintained between 10:00 PM and 6:00 AM.

4. Facilities and Rules

Common Areas:

Lights, fans, and electrical appliances must be switched off before leaving rooms.

Posters or unauthorized items must not be pasted on walls or common spaces.

Use water and electricity wisely.

Hostel Visits:

Male students are strictly prohibited in ladies' hostels and vice versa, except on official duty with valid passes.

5. Leave and Exemptions

Leave Requests: Submit at least three days in advance, with verification by the hostel authorities.

Students within Pune and Pimpri-Chinchwad city limits can apply for hostel exemption during admission with valid residential proof.

6. Safety and Security

Safeguarding Belongings: Students are advised not to keep valuables or large cash (above ₹3,000) in their rooms. Hostel rooms may be inspected or opened by the warden in case of violations, security risks, or emergencies.

7. Disciplinary Actions

Violations of rules, unlawful behavior, or damage to hostel property may result in:

1. Fines.
2. Suspension or cancellation of hostel admission.
3. Expulsion for severe offenses like ragging.

8. General Policies

Students must clear hostel dues before vacating.

Report any roommate or neighbor issues (e.g., illness, unlawful activities) to the warden immediately.

Collecting donations for any purpose is strictly prohibited.

Emergency Information

For emergencies, students must report to the hostel warden or student support staff immediately.

Disciplinary Procedures

If a student is found violating the rules and regulations of the hostel as per the above-mentioned points with regards to damages of hostel, s/he may be subjected to following disciplinary sanctions.

- **Warning:** A written warning mentioning that a minor offence occurred concerning hostel property damage and a repeat offence would invite a severe sanction.
- **Probation:** The student(s) shall be under observation for their behaviour and compliance of all the rules & regulations laid down for the probation period about damages caused to the hostel
- **Fine:** A student may be asked to bear the cost of repairing and/or replacement of damage/loss incurred to the hostel properties
- **Deferred suspension/expulsion:** A period of review during which the repeat offence will result in suspension or expulsion from the hostel.

ATTENDANCE POLICY

General Guidelines

Residents are required to record their attendance via biometric or card systems during entry and exit.

Curfew Timings

Weekdays: 9:30 PM

Weekends: 10:00 PM

Late Entry

- Residents must inform the warden in advance for late entry.
- A penalty of ₹1000 will be charged for unauthorized late entries.
- **Absence Notification:** Any overnight absence must be reported to the hostel warden with written permission from parents/guardians (if applicable).

SECURITY DEPOSIT AND RECOVERIES POLICY

Security Deposit Terms

A refundable security deposit of INR 25000 will be collected at the time of admission.

Recoveries from the deposit will be made for:

- 10% deduction from security deposited will be done as annual maintenance charges.
- **Damages to property:** Charges as per the cost of repair or replacement..
- **Lost items:** Full cost of replacement (e.g., keys, access cards, furniture).
- **Unpaid dues:** Pending rent, utility bills, or penalties.
- **Deep cleaning charges:** If the room is left in an unhygienic condition.
- **Late check-out fees:** ₹500 per day post the official check-out date.

A detailed recovery statement will be shared with the resident prior to deduction.

MEDICAL FACILITIES

Doctor visits the hostel once in a week for students. In case any student requires medical attention, they must immediately inform the caretaker/warden. The student will be given due attention in the form of proper medical care and taken to the hospital if required.

HOSTEL EXIT POLICY

Those who wish to exit the hostel, will have to complete the hostel exit procedure and take acknowledgement for the same before the student leaves the hostel. Students must provide a one-month advance notice of their exit through the designated app or via email. Verbal communication will not be accepted.
